- 1. ACCESS OF THE TREASURER'S OFFICE TO ACCOUNT INFORMATION: The Treasurer's Office, and persons authorized by the Treasurer's Office, shall have access to account information by means of PC, facsimile, or telephone.
  - Treasurer's Office will be required to use a security code to gain access to information and Bank reserves the right to assign such a security code to

Treasurer's Office or to require Treasurer's Office to use such security codes, as a prerequisite for gaining access to information files maintained by Bank.

- b) Treasurer's Office is responsible for safeguarding access to its security codes and account information.
- c) Treasurer's Office shall also have access to such other types of account information, more fully described in Exhibit A.

# 2. ERRORS AND RELAY IN TRANSMISSION OF INFORMATION; LOSS OF INFORMATION.

Bank shall not be responsible for any loss of information or for errors and delays in transmission and or processing of Treasurer's Office account information caused by strike, lockout, war, lack of energy, computer malfunction including but not limited to computer viruses, riot, insurrection, fire, acts of God, governmental acts or regulations or causes beyond its control. Bank shall not be responsible for any error, delay or loss of information caused by any other person or entity not a party to the Agreement. In the event of any errors or delays by Bank, Bank shall only be responsible to use its best efforts to correct any such errors or resume transmissions of information required to be made by Bank as soon as reasonably possible.

IN NO EVENT SHALL BANK BE LIABLE FOR CONSEQUENTIAL DAMAGES RESULTING FROM ANY LOSS OF INFORMATION OR ANY ERRORS OR DELAYS OF ANY PERSON OR ENTITY.

# 3. INFORMATION RECEIVED FROM OTHER FINANCIAL INSTITUTIONS.

If Treasurer's Office requires that Bank accept information concerning Treasurer's Office accounts at other financial institutions, then the Treasurer's Office is responsible for verifying the accuracy of such information and Bank may rely on the information as to its accuracy. Treasurer's Office warrants to Bank that the accounts listed in Exhibit A are the only accounts for which Bank will receive information. Any additions or deletions must be given to Bank in writing.

#### 4. CASH MANAGEMENT SERVICE CHARGES.

Treasurer's Office hereby agrees to pay Bank, for the services provided hereunder, as set forth in Exhibit A.

#### 5. **TERM.**

This Second Amendment shall run concurrently with the Agreement.

#### 6. **GENERAL.**

All other terms and conditions of the Agreement, as amended, shall remain in full force and effect.
